Personal data being processed by us

Amacore B.V. processes personal data in order to be able to deliver our services. The only personal data that we process are: first names, surnames and e-mail addresses.

Peculiar/sensitive personal data being processed by us

Our website and other services do not aim at collecting personal data from minors less than sixteen years old, unless they have approval from parent/guardian. However we cannot determine the actual age of visitors to our website. We therefore advice parents/guardians to closely monitor the online activities of their children to avoid personal data of minors to be collected without the approval of their parents/guardians. Why do we process your personal data?

Amacore B.V. processes your personal data in order to be able to contact you regarding our services, by telephone or e-mail.

Automated decision making

Amacore B.V. does not make decisions with potential significant consequences to individuals based on automated data collection.

Storage period of personal data

Amacore B.V. does not store your personal data any longer than strictly necessary to be able to provide our services.

Sharing of personal data with third parties

Amacore B.V. only releases your personal data to third parties when this is strictly necessary to fulfill our agreements with you as our client or when this is legally required by authorities.

Cookies and comparable techniques used by Amacore B.V.

Amcore B.V. solely uses technical & functional cookies, as well as analytical cookies that do not breach personal privacy. A cookie can be described as a small text file that is saved to an individual computer, tablet or smartphone upon the first visit to a certain website. The cookies being used by us are needed for a fully operational website as well as the functional usability of the website for individuals. These cookies make sure the website remains fully operational and for example keep track of individual user preferences. The data derived from these cookies can be used to optimize our website. You can sign out for the use of cookies on your personal device by adjusting the settings of the web browser used by you. In addition you can also delete all saved cookies from your device via the settings of your web browser.

View, adjust or delete personal data

By Dutch law, you possess the right to view, adjust or delete your personal data. In addition you possess the legal right to withdraw your potential permission for the processing of your personal data or to object against the way Amacore B.V. processes your personal data. Furthermore you possess the legal right on data portability of your personal data. This implies that you can submit a request to receive a full report of exactly which of your personal data we currently store. In order to be sure that any of the previously mentioned potential requests are actually coming from you, we kindly ask you to include a copy of your identification when sending us a request concerning personal data. To safeguard your privacy we suggest to shield off your sensitive person details, such as passport number, personal identity number and the machine readable zone. Upon receiving your request we will respond as soon as possible though ultimately within the time scope of four weeks.
